

2017 Best of Orange County Contest Rules



HOW TO ENTER: Complete the Best of Orange County 2017 online ballot at voteocbest.oregister.com

A total of 5 winners will be selected.

To be eligible to win you must:

- Cast your vote between May 1, 2017 – June 2, 2017
- Complete the online registration form at voteocbest.oregister.com
- Cast a minimum of 10 votes in 10 different categories
- Submit only one online ballot per day

People who share a computer will be able to vote as long as each uses a separate login. Once a winner is selected, he or she is unable to win again. Online ballots must be submitted between May 1, 2017 and June 2, 2017. Winners will be contacted by phone or email between June 9, 2017 and June 16, 2017.

WINNER SELECTION: Five (5) winners will be selected to win a \$100 prize in a weekly random drawing from among all eligible entries. One (1) winner will be selected each week of the promotion (May 1 – June 2, 2017).

NO PURCHASE IS NECESSARY: As an alternate method of entry into the contest you may mail in a 3-inch x 5-inch card on which you have legibly printed your First and Last Name, Complete Mailing Address (e.g. Street, City, State and ZIP Code), Daytime Telephone Number and Email Address (if available).
